- □ PHOTOMETRIC PLAN FOR ILLUMINATED SIGNS demonstrating compliance with Chapter 98, Outdoor Lighting/Dark Sky Ordinance.
- □ SCALED AND DIMENSIONED ELEVATIONS of the signs requiring variance. For attached signs, the elevations shall show the building in full panoramic view with a rendition of the sign and any other signs that conform to or are exempt from the sign ordinance. Existing signs will require a before and after rendition.
